Call for the selection of no. 41 Research Grants assignment

The University of Pisa announces a public selection for the assignment of n. 41 grants for research activities (hereinafter referred as Research Grants) as provided in Annex A. For each research project, candidates will find in Annex A an individual table listing the Department, the research subject, the scientific field, the contract duration and information about the interview. The 50% of the Research Grants will be funded on the FSE POR 2014-2020 resources, in the frame of Tuscan Regional project Giovanisi (www.giovanisi.it), aiming to enhance young people's autonomy. Contract duration: 24 or 36 months, as indicated in each project table.

Gross annual salary: € 27.000,00

Application's deadline: 26/01/2018

Admission requirements:

PhD or equivalent academic qualification awarded in Italy or abroad and recognised as eligible for admission or Medical Specialty School qualification for the relevant medical fields, or a Master Degree plus at least a three- year period of documented research experience in Universities and public or private Research Centres; the three -year period must be already completed by the application's submission; To be under the age of 36 by the application's submission; To have domicile in Tuscany by the application's submission.

If successful, the candidate currently holding other fellowships or research grants, is asked to renounce before the acceptance, without prejudice to the provisions stated in the Italian Law 240/2010, article 22, subparagraph III (exception laid down for scholarships awarded by national or foreign institutions and aiming to complement the research activities with a stay abroad).

This selection does not enable nationality limitations and follows the cross-cutting priorities of gender equality and equal opportunities.

The application shall include:

- a) A training-learning-research project, with the details of the outcomes and professional development the candidate aims to achieve through the participation in the research project selected;
 - b) The candidate's curriculum vitae, with documented details of study and education, research experiences and outcomes achieved (e.g. publications, patents...) self-attested using the TEMPLATE in Annex C;
 - c) All documents and certificates the applicant considers eligible for this selection. Please append original or copies which satisfy the conditions necessary to establish their authenticity (e.g. certified true copy, affidavit), self-attested copies using the TEMPLATE in Annex C, or a self-declaration using the TEMPLATE in Annex D ;
 - d) The publications the applicant considers eligible for this selection. Please append original documents or copies. If copies, applicant shall self-attest they are conforming to the original using the TEMPLATE in Annex C and including a copy of applicant's identity card or passport;
 - e) A list of qualifications and publications;
 - f) A copy of applicant's tax code (If applicable) and identity card or passport;
- All documents, including the Curriculum and the list of Publications and qualifications, shall contain the date and the applicant's signature.

Selection procedure:

For each selection procedure, the Director of the Department concerned will appoint a selection committee.

The selection is assessed by qualifications and an interview.

The committee will evaluate:

- a) The consistency between the training-learning-research project the candidate proposed and the specific research project;
- b) The consistency between the curriculum vitae, the course of study, the research experiences made and the requested project profile;
- c) The academic qualifications, the number and quality of the research results achieved (publications, patents, etc.);
- d) The rating obtained during the interview, which is intended to assess the attitude, the motivation and the background of the candidate in participating in the project.

The rating assigned for points b) and c) shall not be less than 60% of the total rating allowed.

For interviews timetable, please refer to each research grant table annexed to this call.

The failed attendance to the interview will be considered as a voluntary renunciation.

The candidates living abroad and therefore unable to attend the interview at the University of Pisa will be allowed to be interviewed via the web or a conference call, prior applicant's identification by approved international universities or research centres and upon the Selection Committee approval.

The Selection Committee is appointed to establish the duly examination of the candidates and shall acquire each candidate's copy of an identity card or passport

The University of Pisa and the Tuscany Region on the 11th of December 2017 signed an agreement for the implementation of the intervention program "FSE research grants - Tuscany Region". According to the agreement, the research grants will have to start by the 90th day after this signature.
